The City of Florence is accepting sealed bids from licensed and qualified contractors for the S-13 / S-24 (Paper Mill / E. National Cemetery) Utility Relocations project.

CONSTRUCTION TIME LIMIT: 120 Consecutive Days

PROJECT SCOPE: The work to be completed consists of furnishing all materials, equipment and labor necessary for the complete installation of 344 linear feet of new 8-inch PVC water main, 225 linear feet of new 8-inch RJ PVC water main, 202 linear feet of new 12-inch PVC water main, 363 linear feet of new 12-inch DIP water main, 90 linear feet of 12-inch water main in casing, the abandonment of 599 linear feet of 8-inch watermain and 597 linear feet of 12-inch watermain with flowable fill. Additionally, the project includes 505 linear feet of 8-inch PVC sewer force main and 379 linear feet of 8-inch RJ PVC sewer force main, two (2) 8-inch insert valves, one (1) air release valve and doghouse manhole, the abandonment of 901 linear feet of 8-inch sewer force main with flowable fill, and associated driveway replacement.

Bidder must be an official plan holder and on the projects plan holders list for bid to be considered, that is maintained by AECOM Technical Services, Inc.

Bidders must deposit security with all bids. Security shall be in the form of a certified check or bid bond made payable to the Owner in an amount equal to not less than five percent (5%) of the amount of the bid. Provisions of the security shall be as described in the Information for Bidders. A one hundred percent (100%) payment bond and performance bond will be required. Contractor must provide fire, extended

coverage, vandalism, and malicious mischief insurance equal to the actual value of the insured property during construction.

Any prospective bidder, offeror, contractor or subcontractor who is aggrieved in connection with the solicitation of this contract may protest to Engineer (or) Owner in accordance with Section 11-35-4210 of the SC Code of Laws, within 15 days of the date of issuance of the Notice of Intent to Award.

No bid will be considered unless the bidder is legally qualified under the provisions of the South Carolina Contractor's Licensing Law (South Carolina Code of Laws as amended on April 1, 1999, Chapter 11, Sections 40 11 10 through 40 11 428).

Contractors shall have a classification of WL.

No bidder may withdraw the bid within 90 days after the actual date of the opening and thereof.

These bid documents will be modified only by written addenda.

The Owner reserves the right to waive any informalities or to reject any or all bids.
